- Analysis of 2020 EIA Notification and how Ex Post Facto Clearance acts as a hinderance to public participation: I researched and summarized key court judgments on cases challenging ex post facto clearances. I identified patterns in judicial rulings and analyzed how these decisions have shaped the legal framework for public participation in environmental decision-making
- I drafted a policy brief proposing amendments to the EIA Notification that would: (a) explicitly prohibit ex post facto clearances; (b) strengthen public hearing procedures by requiring mandatory public consultations at key stages of project development; and (c) establish an independent Environmental Impact Assessment Authority to oversee the entire EIA process
- Drafted policy documents for India's future roadmap with regards to Climate Action and Wildlife Projects like Project Cheetah: For Project Cheetah, I developed a policy brief on long-term genetic management. This included recommendations for: (a) establishing a robust monitoring program to track cheetah populations and genetic diversity; (b) implementing measures to minimize inbreeding, such as captive breeding programs and potential reintroductions from other source populations; and (c) conducting ongoing research to understand the ecological and social impacts of the reintroduction program
